

Linking your CPD records in the My CPD area (Learning Centre) - example

All aspects of your Continuing Professional Development record should reflect your audit period. Therefore, in most instances, the activities you note in the **Log completed CPD** section will align with what you have identified in the **Plan your CPD** section.

We recommend demonstrating this by numbering your records within the the titles in both the **Plan your CPD** and **Log your CPD** areas so they correspond. In the example below, in the **Plan your CPD** section '1. Asylum seekers' has been identified as an area to learn more about. In the **Log your CPD** section, '1. Working with asylum seekers' has been completed. Both have been numbered '1' to show how the completed activity in the CPD log links to the identified area of development within the CPD plan.

Add a new entry for each area - these will appear below so you can refer to them throughout the year. When you've completed a CPD activity, go to your 'Log completed CPD' log to record it.
